1.03 SUBMITTALS

- A. Submit under provisions of Section 01 30 00.
- B. Product Data:
 - 1. Manufacturer’s printed product data indicating compliance with specified requirements.
- C. Shop Drawings:
 - 1. Submit plans, elevations, and detail sections. Indicate overall dimensions, material thickness, location and size of cutouts, anchorage provisions and attachment methods. Indicate coordination requirements for adjacent and interfacing work.

1.05 DELIVERY, STORAGE, AND HANDLING

- A. Packing and Shipping: Pack Shower Doors, and other flat products in wooden crates to minimize shipping damage. Palletize other components.
- B. Check for shipping damage during unloading at site and notify manufacturer immediately of any obvious damage.
- C. Store products under shelter, off the ground, and protected from moisture. Materials must be at room temperature prior to installation. Handle products to prevent physical damage. Protect surfaces from staining, scratching, and other damage during handling and installation.

1.06 WARRANTY

- A. Seawin Global, LLC shall provide a 5 year warranty from date of purchase on all shower door hardware if the shower door units are install according to our specific installation instructions. Glass Included. Any part deemed to be defective during the warranty period will be provided at no charge. If the units are installed without adherence to our published instructions, the warranty will be null and void on all parts. This warranty does not cover polycarbonates or any claim arising from abuse, misuse, negligence, leakage, abrasives, accidents, improper installation or operation, or natural disaster.

4. MATERIALS

- a. Tempered, clear glass, frosted with polished edges (5/16,3/8)
- b. Polycarbonate water proof seal strips
- c. Back to Back Handles and Towel Bar (stainless steel)
- d. Solid Brass Glass Mount Self-Closing Hinges (stainless steel)
- e. Aluminum U-Channel on two sides on inline panel
- f. Size: Refer to Drawings for width and height

5. Finish (choose one)

- a. Chrome
- b. Brushed Stainless
- c. Satin Black
- d. Champagne Bronze

Part 3 EXECUTION

3.01 Preparation

- A. Refer to shop drawings. Install wood blocking securely in the specified locations.
- B. Field Measurements must be provided by General Contractor or Installer

3.02 Installation

- A. Install the frameless glass in accordance with manufacturer's printed instructions.
- B. Install true, plumb, and level, securely and rigidly anchored to substrate in accordance with manufacturer's instructions for each item and each type of Substrate construction.
 1. Wood blocking shall be provided for the metal U-Channel as shown on drawings.
 2. Strap metal is not acceptable for blocking
